A portion of the fee is a donation to the Friends of SaddleBrooke Libraries. Gratuities for local tour guides, the bus driver and tour directors are not included in the tour fee.

Reservations are on a first come, first served basis and are limited to 50 people. Once that number is reached a waiting list will be established and you will be notified if a cancellation occurs.
